

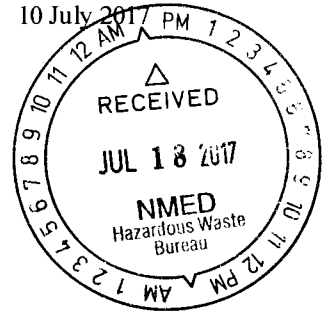

As required by the New Mexico Hazardous Waste Regulations, Holloman Air Force Base (HAFB) is notifying you that it has submitted a Class 3 Permit Modification Request to the New Mexico Environment Department (NMED) for its existing Resource Conservation and Recovery Act (RCRA) Permit No. NM6572124422. The Permit Modification Request addresses the proposed change in status from Corrective Action Required to Corrective Action Complete for one Area of Concern and four Solid Waste Management Units at HAFB. If approved, the NMED will initiate a Class 3 permit modification to the HAFB RCRA permit. The attached announcement is provided as notification.

You are encouraged to attend the public meeting that will be held on 2 August 2017 at 6:00 PM in the Sergeant Willie Estrada Memorial Civic Center (800 E. First St., Alamogordo, NM); and to review copies of the Permit Modification Request available at the Alamogordo Public Library (920 Oregon Ave., Alamogordo, NM) throughout the 60-day public review period.

PUBLIC NOTICE
RCRA PERMIT MODIFICATION REQUEST
1 AREA OF CONCERN AND 4 SOLID WASTE MANAGEMENT UNITS
AT HOLLOMAN AIR FORCE BASE

Notice of a Resource Conservation and Recovery Act (RCRA) Class 3 Permit Modification Request from Holloman Air Force Base (HAFB), in Otero County, New Mexico (NM). HAFB submitted Corrective Action Complete Petitions (Petitions) to the New Mexico Environment Department (NMED) requesting a change in status for one Area of Concern (AOC) and four Solid Waste Management Units (SWMU) at HAFB.

The sites described in the Petitions include:

- Former T-38 Test Cell Oil/Water Separators: SWMU 19 (OW968) and SWMU 20 (OW967),
- Missile Fuel Spill Area, Building 1176 Pond: SWMU 165 (SS039),
- Test Maintenance Area SWMU 137 (OT038), and
- Early Missile Test Site AOC-L (OT037).

The Petitions summarize investigation and remediation activities at the sites, and request a Class 3 Permit Modification to change the status of the one AOC and four SWMUs from Corrective Action Required to Corrective Action Complete *with* or *without* Controls. The purpose of this notice is to inform the public of HAFB's permit modification requests and to offer the public an opportunity to review and comment on the Petitions.

Public Comments: A 60-day public comment period has been initiated with the publication of this notice. The 60-day public comment period extends from July 16, 2017 through September 14, 2017. Only comments and/or questions received on or before the close of September 14, 2017 will be considered.
