

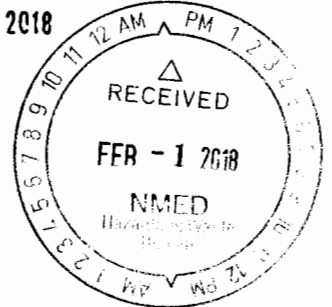

AFFIDAVIT OF COLONEL HOUSTON R. CANTWELL, 49TH WING COMMANDER

PER 20.4.2.21(A) NMAC, the annual fee shall be waived for Hazardous Waste Management units for which the owner provides documentation to the New Mexico Environment Department (NMED) that Resource Conservation and Recovery Act (RCRA) related waste management activities did not occur at the unit during the previous calendar year.

The following facility under Holloman AFB management did not and will not perform RCRA-related waste management activities during 2017: the Open Detonation Unit. The Open Detonation Unit ceased operations since 2010 and currently is in the process of closure with NMED.

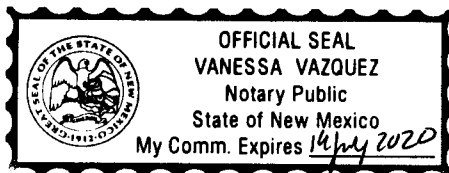
