The New Mexico Environment Department (NMED) has reviewed the above referenced request dated April 23, 2018 for a two-year extension of time to submit a Resource Conservation and Recovery Act Facility Investigation Work Plan (RFI WP) for the identification and characterization of subsurface anomalies discovered at Site LF029 (SWMU 104). The reason for this request is to allow time for the U.S. Army Corps of Engineers to identify and remove unique munitions that have been encountered. Once munitions have been cleared, a RFI WP is to be submitted to address the characterization of remaining subsurface anomalies and any soils or groundwater impacted by munitions constituents. NMED hereby grants this request with the new RFI WP submittal date of **May 1, 2020**.
