The New Mexico Environment Department (NMED) received Holloman Air Force Base *Request for an Emergency Authorization to Destroy Military Explosive of Concern (MEC)* on February 20, 2023. The NMED accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. The NMED reviewed the submittal in accordance with 20.4.2.201.B(3) NMAC and issued Emergency Permit 2023-06 on May 12, 2023.. The fee invoice for issuance of the Emergency Permit is attached to this letter.

Payment is due within sixty (60) calendar days from the date that you receive the invoice in accordance with 20.4.2.301.C NMAC. If you disagree with the fee assessed, you may notify the NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Ms. Jessi Sanchez, NMED Hazardous Waste Bureau, at the address below indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
