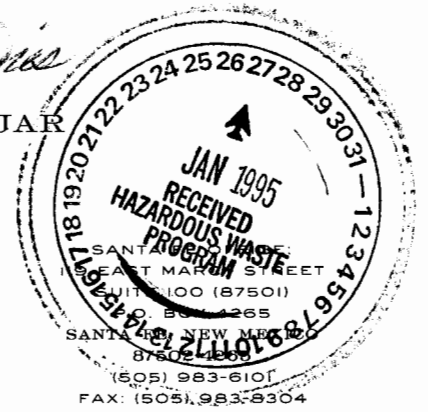

Dear Ms. Hoditschek:

This letter follows Jan Appel's letter to you dated December 15, 1994 in which he confirmed to you that Mr. Vince Malott at EPA Region VI in Dallas had told us that Sparton would be receiving before Christmas comments from EPA on the corrective measures study submitted to EPA in November, 1992. To date, we have not received any comments from EPA.


We promised you in our letter that if we did not receive comments of EPA before Christmas, we would contact you to discuss further scheduling of the matter. Sparton was informed last Friday by EPA that Sparton will receive EPA's comments by no later than February 3, 1995. Assuming receipt of EPA comments by February 3, we request that Sparton be granted an extension to file its application until a period of time between thirty (30) to sixty (60) days after receipt of EPA comments. Once EPA comments are received, we will be in a position to confirm a specific schedule for you.
