Dear Mr. Stranko:

The Hazardous Waste Bureau (HWB) of the New Mexico Environment Department (NMED) is requesting that Sparton Technology, Inc. (Sparton) submit the following documents to HWB in an expeditious manner.

- 1) In reference to the letter from NMED to Sparton dated December 11, 2001, Sparton is required to demonstrate liability coverage as required by 20.4.1.500 NMAC (incorporating 40 CFR 264.147 (f)). This information was required to be sent to NMED within 15 days of receipt of the December 11, 2001 letter, which according to certified mail receipt was December 14, 2001. No request for a time extension or the requested information has yet been received by NMED.
- 2) In reference to the Request for Supplemental Information (RSI) letter dated June 22, 2001, Sparton informally notified NMED that the RSI submittal date to NMED was to be December 7, 2001. Dialogue between NMED and Sparton has resulted in several additional deadlines for document submittal which have not been met by Sparton.

- 3) In reference to the letter from NMED to Sparton dated September 26, 2001, Sparton is required to submit changes to key Sparton personnel such as those specified in the Permit Application and attached documents to NMED for notification purposes. Sparton has indicated that these changes will be provided to NMED but as of this date has not submitted the requested information.
- 4) In reference to the Old Drum Storage Area closure, Sparton has performed all requested actions leading to the clean closure of the Old Drum Storage Area except for the submission of confirmatory soil sampling results and the professional engineers letter addressed to NMED certifying clean closure.

Please submit the above requested information to NMED no later than February 15, 2002.
