The Hazardous Waste Bureau has completed the Draft Annual Unit Audit for calendar year 2000 concerning the WIPP Facility. Tables developed as a result of the Draft Annual Unit Audit are enclosed. A thirty-day comment period is being provided by the Hazardous Waste Bureau for your facility to identify any discrepancies in the tables. Any comments identifying discrepancies in the tables is due by the close of business thirty days from your receipt of this Draft AUA. Should the Return Receipt Requested card be returned without a date of receipt the comments are due by the close of business thirty days from the date of this letter. At this time we ask only for your input on the accuracy of the enclosed tables.

Under the provisions of 20.4.2.201 NMAC the AUA is also used to determine the Annual Hazardous Waste Management Business Fee (AHWMBF) for your facility. **Do not calculate and submit the AHWMBF based on these tables.** An invoice will be mailed with the Final Annual Unit Audit on June 29, 2001. Your facility will have thirty days from receipt of that document to file an appeal of the Final AUA. Your facility will have sixty days from receipt of the invoice and the Final AUA to submit the AHWMBF fee.
