NOTIFICATION OF THE SUBMITTAL OF A CLASS 1 PERMIT MODIFICATION TO THE STATE OF IDAHO DEPARTMENT OF ENVIRONMENTAL QUALITY

Dear Concerned Citizen:

Notice is hereby given that BNFL Inc. (i.e., the operator/owner) and the U.S. Department of Energy, Idaho Operations Office (DOE-ID) (i.e., the landowner), hereinafter collectively referred to as the Permittee, submitted a Class 1 Permit Modification Notification to the State of Idaho, Department of Environmental Quality (DEQ) on or about November 10, 2004. The Permit Modification proposed modifications to the Final Hazardous Waste Management Act (HWMA)/Resource Conservation and Recovery Act (RCRA) Treatment Permit for the Advanced Mixed Waste Treatment Project (AMWTP) located at the Radioactive Waste Management Complex (RWMC) on the Idaho National Engineering and Environmental Laboratory (INEEL), hereinafter referred to as the AMWTP HWMA/RCRA Treatment Permit. The changes proposed in the Permit Modification became effective on October 29, 2004.

This Permit Modification addresses proposed revisions to the AMWTP HWMA/RCRA Treatment Permit related to the turnover of operational activities of Waste Management Facility (WMF) – 610 from BNFL Inc. to Bechtel BWXT Idaho LLC (BBWI). This Permit Modification also incorporates information from equivalent or superior determinations made in accordance with Permit Condition II.P since the submittal of the last permit modification to the AMWTP HWMA/RCRA Treatment Permit.
