STIPULATED POST-HEARING SCHEDULING
AND PROCEDURAL ORDER

This Post-Hearing Scheduling and Procedural Order sets forth the schedule and procedures for the post-hearing briefing in this proceeding on the proposed Hazardous Waste Facility Permit for the Waste Isolation Pilot Plant that the New Mexico Environment Department proposes to issue to the United States Department of Energy and Washington TRU Solutions LLC under the New Mexico Hazardous Waste Act, NMSA 1978, §§ 74-4-1 to 74-4-14.

1. Post-hearing briefs, including closing arguments, shall be due on September 22, 2010, thirty days after the filing of the hearing transcript. Post-hearing briefs shall be limited to thirty pages, double-spaced, with twelve point type, and with one inch margins.
2. Proposed findings of fact and conclusions of law shall be due on September 22, 2010, thirty days after the filing of the hearing transcript. Each proposed finding and conclusion shall be individually numbered. There shall be no page limit on proposed findings of fact and conclusions of law.

3. All papers shall, at a minimum, be served on all other parties by electronic mail.
4. Parties shall provide the Hearing Clerk with two paper copies and an electronic version in Microsoft Word format of all papers filed.
5. Extensions of the deadlines set forth in this Order will be disfavored, and motions for extensions of time will be granted at the discretion of the Hearing Officer only upon a showing of good cause.


