Here are my comments:

1. I believe the report would benefit from having a Table of Contents to point out the page numbers for:
 - a. Introduction
 - b. Discussions
 - c. Well hydrographs and data
 - d. References
2. Does Figure 1 need a scale?
3. Well H-07b1, page 14: is "water well on same pad" the same as "approximately 100 feet away" page 3, 4th paragraph
4. Page 17: There is no hydrograph or place holder for well H-11b4R even though it is listed in Table -1 on page 1

We can discuss this next week. I'm thinking we can let the Permittees know that we would like some of these in their next report.
