The New Mexico Environment Department (NMED) has received the *2021 Annual Groundwater Monitoring Report*, dated March 31, 2022, and received on April 13, 2022. If payment is transmitted electronically, then you must submit a letter to Mr. Dave Cobrain, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
