The New Mexico Environment Department (NMED) has received the *Area of Concern 17 – Railroad Loading/Unloading Facility Investigation Work Plan*, dated January 10, 2023, and received on January 12, 2023. The NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC.
