The New Mexico Environment Department (NMED) has received the *French Drain Soil Sampling Investigation Report*, dated March 31, 2023, and received on March 30, 2023. The NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC.
