The New Mexico Environment Department (NMED) has received the *Solid Water Management Unit 2 – Evaporation Ponds Investigation Work Plan*, dated March 15, 2023, and received on March 23, 2023. The NMED has accepted the submittal for review in accordance with the New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2) NMAC. NMED will review the submittal after the appropriate fees have been received. The fee invoice is attached to this letter.
